

The meeting of the Electoral Board of Surry County, Virginia, Wednesday, March 6, 2024 at 10:00 A.M in the Registrar's office. Lynita Mason, Chairman, William Etchison, Vice-Chairman, Donna Skinner, Secretary, Sharna White, Registrar, Russell Dabney, Deputy Registrar, Lynetta Davis, Election Officer were present.

The purpose of the meeting is to review, confirm and record the official local results of the Dual Presidential Primary held on Tuesday, March 5, 2024 (AUTHORITY: Section 24.2-671 of the 1950 Code of Virginia, as amended)

The meeting was called to order by the Chairman at 10:06 A.M.

Motion was made by Vice-Chairman Etchison to approve the Order of Business with the following addition: Provisional Ballot Meeting to New Business. Motion was ADOPTED.

10. Verified receipt of election equipment- SEALED and SECURED in the Registrar's office
