- Public Hearing to Consider Adopting an Ordinance to Establish Twice A Year Tax Billing for Real Estate and Personal Property** - A public hearing is being held to consider an ordinance to establish a twice-year billing cycle for real estate and personal property taxes. This means that the current annual tax payment due on December 5th each year, will be split into two payments, dividing the yearly tax payment into smaller increments (June 5th and December 5th). If approved, this will be effective for Tax Year 2025, which means the first 1/2 payment will be due in June 2025 and the second 1/2 payment will be due in December 2025. The December 2024 full
